

Privacy Policy

We at Umujyi.com are committed towards protecting our customer's personal information and / or sensitive personal data and strive to maintain the privacy of your personal information we collect from you from your visits to the UMUJYI.COM Web and Mobile Application. Personal information is any information that can be used by itself to uniquely identify, contact, or locate a person, or can be used with information available from other sources to uniquely identify an individual.

UMUJYI.COM way of using information
